- Asia-Pacific markets traded mostly higher Monday, mirroring Wall Street's Friday gains, as investors weighed China's latest lending rate decision (Source: CNBC).
- Oil prices edged up Monday, supported by geopolitical tensions in Europe and the Middle East, though supply expectations and tariff concerns capped gains (Source: Reuters).
- Gold hovered near record highs Monday as markets awaited Fed speeches and US inflation data, after last week's rate cut and signals of further easing (Source: Reuters).

Saudi commentary

- The Tadawul All Share Index (TASI) gained 0.26% to close at 10,808.68. Sixteen of twenty-one sector indices advanced, led by Pharma, Biotech & Life Science (+2.11%) and Consumer Services (+2.03%), while Banks (-1.07%) and Software & Services (-0.50%) were the main laggards. Market breadth was weak at 166/76, with turnover at SAR 4.7bn.
- **Sipchem** suspended operations at its International Methanol Co. (IMC) plant for scheduled periodic maintenance as part of routine preventive measures (Source: Tadawul).
- Alkhaleej Training signed an exclusive licensing deal with Dusit Thani College, Bangkok, to offer hospitality and tourism vocational training programs in Saudi Arabia (Source: Tadawul).
- Naba Alsaha awarded two Phase III contracts for its Al-Munsiyah hospital project in Riyadh to Arabian Air Conditioning Co. Ltd. (Carrier) and Dallah Trading Co. (Source: Tadawul).
- Enma AlRawabi Co. unveiled a new corporate identity and rebranded as INMAR Co. for Real Estate Development and Investment (Source: Tadawul).
- Ladun Investment Co. stated it does not expect a material impact from the implementation of the amended Idle Land Tax Law (Source: Tadawul).




